

Entry requirements

- 1. Entrants must reside in Timboon and District Healthcare (TDHS) catchment area See map (below)
- 2. Entrants must qualify as amateur photographers. 'Amateur' is defined as not currently earning primary income as a photographer.
- 3. Each entrant may submit **no more than two entries** in the competition.
- 4. Photographs entered in the competition must respond to the competition theme, that being a combination of:
 - 1. Timboon and District Healthcare Service's Vision Statement: *Enabling optimum Health & Wellness for our communities*And
 - 2. Depicting location/s or aspects of Timboon and District Healthcare Service's catchment area. See map (below)



- 5. Photographs must have been taken by the entrant submitting them.
- 6. Photographs containing images of people must be accompanied by their signatures in the release section of the entry form. Photograph's featuring people under the age of 18 must also have release consent from a parent or guardian. Any entry featuring people without release consent will be deemed invalid.
- 7. Photographs may have been taken at any time.
- 8. Photographs may be submitted in either black and white, or colour.
- 9. Photographs may be submitted in a range of digital formats E.G. JPG, TIFF, PNG
- 10. All submitted images must be of high quality/resolution for reproduction purposes.
- 11. All entries are submitted to the judging panel anonymously and must therefore not be marked in any way with the entrant's name. This includes watermarks.
- 12. Entries must be submitted via email to gmcdonald.tdhs@swarh.vic.gov.au when the competition opens. Files on DVD, CD or USB will not be accepted. Faxed or physically mailed entries will not be accepted. Entrants can request assistance with submitting entries by contacting TDHS.
- 13. Entrants must provide a valid return email address and phone number for ease of correspondence.
- 14. Entrants must agree to these entry requirements and the terms and conditions of entry when entering the competition.
- 15. Entrants aged less than 18 years at the commencement of the competition must have obtained written and signed parental or guardian permission on the entry form.

Terms and conditions

- 1. By entering the competition, entrants agree to these terms and conditions of entry.
- 2. This competition is delivered by Timboon and District Healthcare Service (TDHS), 21 Hospital Rd, Timboon Victoria 3268.
- 3. The prize pool consists of 1^{st} prize (1 x \$150) 2^{nd} Prize (1 x \$75) & 3^{rd} Prize (1 x \$30).
- 4. While entry is open to employees of TDHS, such entries are ineligible for prize money.
- 5. Any entry of an entrant under the age of 18 who does not provide the required parental or guardian consent will be deemed invalid. These terms and conditions of entry will bind such parent or guardian.
- 6. The competition opens Monday 4 June 2018, and closes Monday 16 July 2018, 5pm
- 7. An entrant may submit up to two entries but there is only one major prize.
- 8. TDHS will not be liable for any images lost or corrupted as part of submission. It is the entrant's responsibility to maintain original copies of any images submitted.
- 9. No responsibility is accepted by TDHS for late, lost or misdirected entries.
- 10. Images that are considered of an offensive nature will be rejected and if deemed necessary reported to authorities.
- 11. Entrants retain the copyright of any images submitted, however TDHS reserves the right to exhibit and publish <u>all entries</u> within the context of the competition. By entering the competition, entrants authorise TDHS to publish any images within the Annual Report and on other promotional material, both in print and electronically. In all such cases, every reasonable effort will be made to acknowledge the source of the photograph/s.
- 12. The judges' decision is final; no correspondence will be entered into.
- 13. The winners agree to participate as required in promotional activities relating to the competition, including but not limited to, being interviewed and photographed. The winners agree to grant TDHS a perpetual and non-exclusive licence to use such footage and photographs in all media worldwide.
- 14. TDHS reserves the right to request that the winners provide proof of identity, prior to distribution of the prizes. The verifications required are at the sole discretion of TDHS and if these requirements cannot be satisfied, the winners will forfeit the prizes in whole and no substitute will be offered or compensation paid.
- 15. TDHS reserves the right to withdraw a prize in the event that an entrant claiming to be a winner is unable to satisfy the entry requirements or these terms and conditions.
- 16. TDHS will make all reasonable efforts to deliver prizes to the winning entrants.
- 17. Prizes are non-transferable.
